- 1. Taking into consideration the performance reflected in the examination (Online Test), number of post advertised, horizontal and social reservation etc., the provisional list of the candidates to be considered for selection and wait list for the post of **Assistant Engineer (Civil) is prepared.**
- 2. The candidates have been provisionally selected / waitlisted on the basis of performance reflected in the on-line written test held on 13.01.2018, which is subject to verification of documents /certificates. If candidate fails to submit all the required documents /certificates at the time of their document verification, he / she will be held disqualified from selection process.
- 3. The candidates considered for selection shall be called personally for verification of their documents at the Corporate Office, Mumbai for which separate notification shall be given in our website and will also be intimated through e-mail on their e-mail address given in their application form.
- 4. Before coming for document verification, the candidates should ensure that they fulfill all eligibility criteria as mentioned in the advertisement. The selection of the candidate is purely on provisional basis subject to conforming the pre-requisites and other conditions notified in the advertisement. If it is found that any candidate is not meeting the requirement of pre-requisites or not fulfilling any of the conditions, or he / she has knowingly or willfully furnished incorrect or false particulars / fake certificates or suppressed material information, his / her candidature shall be liable for cancellation without any notice or assigning any reasons whatsoever.
- 5. The qualification acquired by the candidate and other required documents submitted by the candidate must be valid on the cutoff date / last date of application as mentioned in the advertisement. If it is found that candidate has not acquired qualification before cutoff date / last date of application or the documents submitted by the candidate are not valid on the cutoff date / last date of application, he/she shall be treated as disqualified and his / her candidature will be cancelled.

At the time of document verification, if it is found that the candidates who have been provisionally considered for selection are not eligible for further selection process, then wait listed candidate will be called for document verification.
