## INDIAN ECONOMIC SERVICE/INDIAN STATISTICAL SERVICE EXAMINATION 2015

On the basis of the result of the written part of the Indian Economic Service/Indian Statistical Service Examination 2015 held by the U.P.S.C. in May, 2015, the candidates with the under mentioned Roll Numbers have qualified for Interview/Personality Test.

2. The result of those candidates who belong to JAT community and had applied under OBC category in accordance with the Ministry of Social Justice and Empowerment Resolution NO. 20012/129/2009/BC.II, dated 04.03.2014, is **PROVISIONAL** and subject to the Judgment dated 17<sup>th</sup> March, 2015 of the Hon'ble Supreme Court of India in which the said Resolution has been quashed.

3. Further, the candidature of all these candidates who have qualified for Interview/Personality Test is **PROVISIONAL** subject to their being found eligible in all respects. The candidates would be required to produce the original certificates in support of their claims relating to age, educational qualifications, community, physical disability and other documents such as Attestation Forms and TA Forms, etc. at the time of the Personality Test. The formats of SC/ST/OBC & PH certificates, Attestation Forms and TA Form, etc. can be downloaded from the website of the Commission. They are, therefore, advised to keep the said certificates ready with them.

4. In accordance with the Rules of examination, all these candidates are required to fill up the Detailed Application Form (D.A.F.), which is available on the Commission's Website <a href="http://www.upsc.gov.in">http://www.upsc.gov.in</a> and submit the same ONLINE. The DAF will be available on the website of the Commission from 17.07.2015 to 27.07.2015 till 11.59 PM. Important instructions regarding filling up of the DAF and submitting the same ONLINE to the Commission will also be available on the website. The candidates who have been declared successful have to first get themselves registered on the relevant page of the website before filling up the ONLINE Detailed Application Form. The qualified candidates are further advised to refer to the Rules of the Indian Economic Service/ Indian Statistical Service Examination 2015 published in the gazette of India, dated 21.02.2015, which are also available on the website of the Commission.

5. After submitting the DAF duly filled in ONLINE, the candidates are required to take a printout of the finally submitted DAF separately and will have to send the printed copy of the DAF, duly signed by the candidates on each page, along with all relevant documents, to the Under Secretary (IES/ISS), Union Public Service Commission, Dholpur House, Shahjahan Road, New Delhi-110069, so as to reach the Commission's Office latest by31.07.2015. The envelope containing the printout of the DAF submitted ONLINE should be superscribed "DAF for Indian Economic Service/Indian Statistical Service Examination 2015". It can also be delivered at UPSC by hand till 03.08.2015 (5.00 P.M.). In the event of non-receipt of ink singed copy of the DAF, the candidature will be cancelled without any further notice.

6. The candidates are also required to bring the printed copy of the DAF duly signed (by the candidate) along with original documents and a photocopy each thereof at the time of Interview. The instructions for filling up DAF available on the website along with the Rules of the Indian Economic Service/Indian Statistical Service Examination 2015 must be read carefully with regard to the certificates that are to be produced at the time of Interview. The candidate will be solely responsible for not producing sufficient valid proof in support of his/her age, date of birth, educational qualifications, caste (SC/ST/OBC) and Physically disability status.

7. Interviews of candidates who have qualified for the Personality Test are likely to be held in the month of August, 2015. The exact date of interview will, however, be intimated to the candidates through e-Summon Letters. Roll Number-wise Interview Schedule will also be made available on Commission's website in due course.

# 8. No request for change in the date and time of Personality Test intimated to the candidates will be entertained under any circumstances.

9. The mark-sheets of candidates who have not qualified, will be put on the Commission's website within 15 days from the date of publication of the final result (after conducting Personality Test) and will remain available on the website for a period of 60 days.

10. The candidates can access the marks-sheets after keying in their Roll Numbers and date of birth. The printed/hard copies of the marks-sheet would, however, be issued by UPSC to candidates based on specific request accompanied by a self-addressed stamped envelope. Candidates desirous of obtaining printed/hard copies of the marks sheets should make the request within thirty days of the display of the marks on the Commission's website, beyond which such requests would not be entertained.

11. The candidates are advised to notify changes in their address, if any, to the Commission immediately through letter or e-mails.

12. The result will also be available on the U.P.S.C.'s website <u>http://www.upsc.gov.in</u>.
